CHAPTER 1 – GENERAL

These Rules define the additional and/or substitutive procedures applied by RINA for the certification of Quality Management Systems in relation to what is already defined in the Document General Rules for the Certification of Management Systems RC/40

RINA issues certification in accordance with the requirements of the ISO/IEC 17021-1:2015 Standard to organizations whose Management System has been recognized as fully conforming to all the requirements of the Standard:

CHAPTER 2 - REFERENCE STANDARD / CERTIFICATION REQUIREMENTS

According to what is stated in the General Rules for the Certification of Management Systems, to obtain RINA certification a Quality Management System must first and henceforth satisfy the requirements of ISO 9001 and the additional requirements of Accreditation Bodies (e.g.: ACCREDIA documents RT 05 "Requirements for the accreditation of Bodies operating the assessment and certification of management systems for the quality of construction and installation companies of systems and services" (IAF28), RT 21 "Requirements for the accreditation of Bodies operating the Certification of the Quality Management System (QMS - IAF34) of organizations that carry out verification activities on the design of public works, for the purpose of validation / approval"....).

and must make them available to RINA together with the related corrective actions undertaken during the periodic audits.
